Question 1: Shall the Town of Dudley be allowed to assess an additional six thousand dollars (\$6,000) in real estate and personal property taxes for the purpose of energy/utility costs for the fiscal year beginning July first, two thousand and thirteen?

QUESTION 2. "Shall the Town of Dudley be allowed to exempt from the provisions of proposition two and one-half, so-called, the amounts required to pay the Town's allocable share of the bond issued by the Southern Worcester County Regional Vocational School District for the purpose of paying costs of designing, constructing, originally equipping and furnishing an addition to and renovation of the Bay Path Regional Vocational Technical High School, located at 57 Old Muggett Hill Road, Charlton, including the payment of all costs incidental or related thereto?"
