


QUESTION 1. "Shall the Town of Dudley be allowed to exempt from the provisions of proposition two and one-half, so-called, the amounts required to pay the Town's allocable share of the bond issued by the Dudley-Charlton Regional School District for the purpose of renovating the recreational facility, track, athletic-field lighting and concession stand, including the payment of all costs incidental or related thereto, which borrowing shall be reduced by any grants or gifts received by the District on account of that project.
