**QUESTION 1**  
Shall the Town of Dudley be allowed to assess an additional \$2,668,797.00 in real estate and personal property taxes for the purposes of operational expenses for the Town of Dudley in the amount of \$1,674,514.00 and for the purposes of operational expenses for the Dudley-Charlton Regional School District in the amount of \$994,283.00, for the fiscal year beginning July 1, 2023?  
And provided, further, that said question shall be deemed approved if a majority of persons voting shall vote "yes".

**QUESTION 2**  
Shall the Town of Dudley be allowed to assess an additional \$463,000.00 in real estate and personal property taxes for the purposes of funding the Town's share of the costs of a High School Feasibility Study by the Dudley-Charlton Regional School District, as required under the Massachusetts School Building Authority School Building Grant Program and as recommended by the Dudley-Charlton Regional School Committee, for the fiscal year beginning July 1, 2023?
