Graves Engineering went out to inspect the site on March 23rd and found a fair amount of dust at the construction site. Richard Clark from 65 Airport Rd mentioned to the Board that he has a concern regarding the water at the subdivision site. The Town Planner suggested that the Highway Superintendent do a site visit to determine the water concern.

Thomas Chojnacki moved to approve the one-year extension for Legacy Landing/Country Club Acres. Steve Watroba seconded. 3-0-1, motion passed.

- SEP Solar, Oxford Avenue: Inspection report from Graves Engineering came found the construction was underway and there were no major concerns.

3. Discussion of Zoning Articles for Town Meeting:

• Re-zoning a portion of the Conservation District to RES 87: Invitation sent to homeowners in the district.

Mr. Carlson of 15 Marsh Rd had concerns regarding the land being re zoned to RES 87. He believes the area is mostly wetlands and has vernal pools; he believes any development would harm the ecosystem.

The Planning Board reassured him that the Conservation Commission would not permit any work with in the 100 feet wet land buffer zone. The Planning Board wanted the neighbors' opinion on the rezoning of the area in which some residents homes are now nonconforming.

Christopher Marsh from 239 Dudley Oxford Rd. commented that the neighbors would like to keep the Conservation District as is because the area is a watershed and is also a pathway for local wildlife. Mr. Marsh doesn't want development to come in and change the area.

Dale Roemer from 235 Dudley Oxford Rd. had a concern about destroying the ponds and streams that run through the property.

Karen-Beth Gillon from 244 Dudley Oxford Rd. commented that her family has been living at the current land for 4 generations and the area has always been wetlands and is a watershed for the pond. Karen-Beth clarified that part of her family land was taken by eminent domain in 1956 for flood control by the Army Corps of Engineers because the land was not suitable for building because it was so wet.

- Southbridge Road Business 15 Overlay District: No comments
- Revision of Aquifer Protection District: Scott Zajkowski, Chair of the Water Sewer Commission, has looked at the new proposed Aquifer Protection District. The purpose was making a science-based overlay district revision. His board has endorsed the change.

• Mason Road Project has been advertised and construction will start shortly after the award.

- Solar Array Site Plans at the Town's landfill have been submitted and the Town Planner scheduled the public hearing for May 11th 2022.
