1. Call to Order, Pledge of Allegiance:

2. Welcome New Board Members/Swearing In:

Steven Sullivan motioned to approve the modified Consent Agenda as presented. Kerry Cyganiewicz seconded. Unanimous 5-0. The Consent Agenda consisted of accepting the minutes of May 24, 2022, One Year Reappointments and Three Year Reappointments.

John Marsi motioned to appoint John Mrazik (term to expire June 30, 2024) and Karen -Beth Gillon (term to expire June 30, 2025) as members of the Dudley Historical Commission. Steven Sullivan seconded. Unanimous 5-0.

7. <u>Licenses / Permits:</u>

Outdoor Entertainment License – The Greatest Hits Grand Opening – Nick Adamopoulos, Esq. came before the Board representing The Greatest Hits Cannabis Dispensary. They will be having DJ music and live music on the weekend of Friday, June 24, 2022 and Saturday, June 25, 2022. There will be no consumption on the premise and will have food trucks and music. John Marsi motioned to approve the request to The Greatest Hits for an Outdoor Entertainment License for Friday, June 24, 2022 from noon to 8pm and Saturday, June 25, 2022 from noon to 8pm for live music and DJ music. Steven Sullivan seconded. Unanimous 5-0.

8. New Business:

- a. **DCRSD Capital Projects** –Superintendent Lamarche and school committee members from Dudley came before the Board. Phase 1 2002 Request for new roofs, fire panels, radio communication and cameras. The last rounds of capital improvements were over 20 years ago, there is much deferred maintenance that needs to be addressed. The current requests will need a debt exclusion/override, is approximately \$2,826,655 which includes a new roof on Dudley Middle in the amount of \$2,242,500 along with professional fees of \$179,400. Repairing the current roofs are not recommended because current repairs are not holding, as evidenced by the amount of wet insulation increasing 800%– 900% over a span of six (6) years. Fire alarm panels and devices in Dudley Middle, Dudley Elementary and Mason Rd for a total of \$192,400; cameras and video infrastructure \$109, 848 and radio communications for \$27,467. What is not included is funds for renovations at Shepherd Hill, Funds for MSBA Feasibility Study and Athletic Field Bleachers at Carmignani Field Mr. Lamarche stated that he would like to have an election, coinciding with Charlton, for these projects to move forward.
 - b. **Vote on Date for Special Town Meeting** Per Article 1 § 95-1 the Board of Selectmen need to adopt a date during a meeting in June for the Special Town meeting in the fall. John Marsi motioned to hold the Special Town Meeting at Shepherd Hill auditorium on Monday, October 24, 2022. Steven Sullivan seconded. Unanimous 5-0.
