Notice of Joint Town Meeting for the Dudley Charlton Regional School District to consider a budget for FY 24 pursuant to M.G. L., c. 71, section 16B

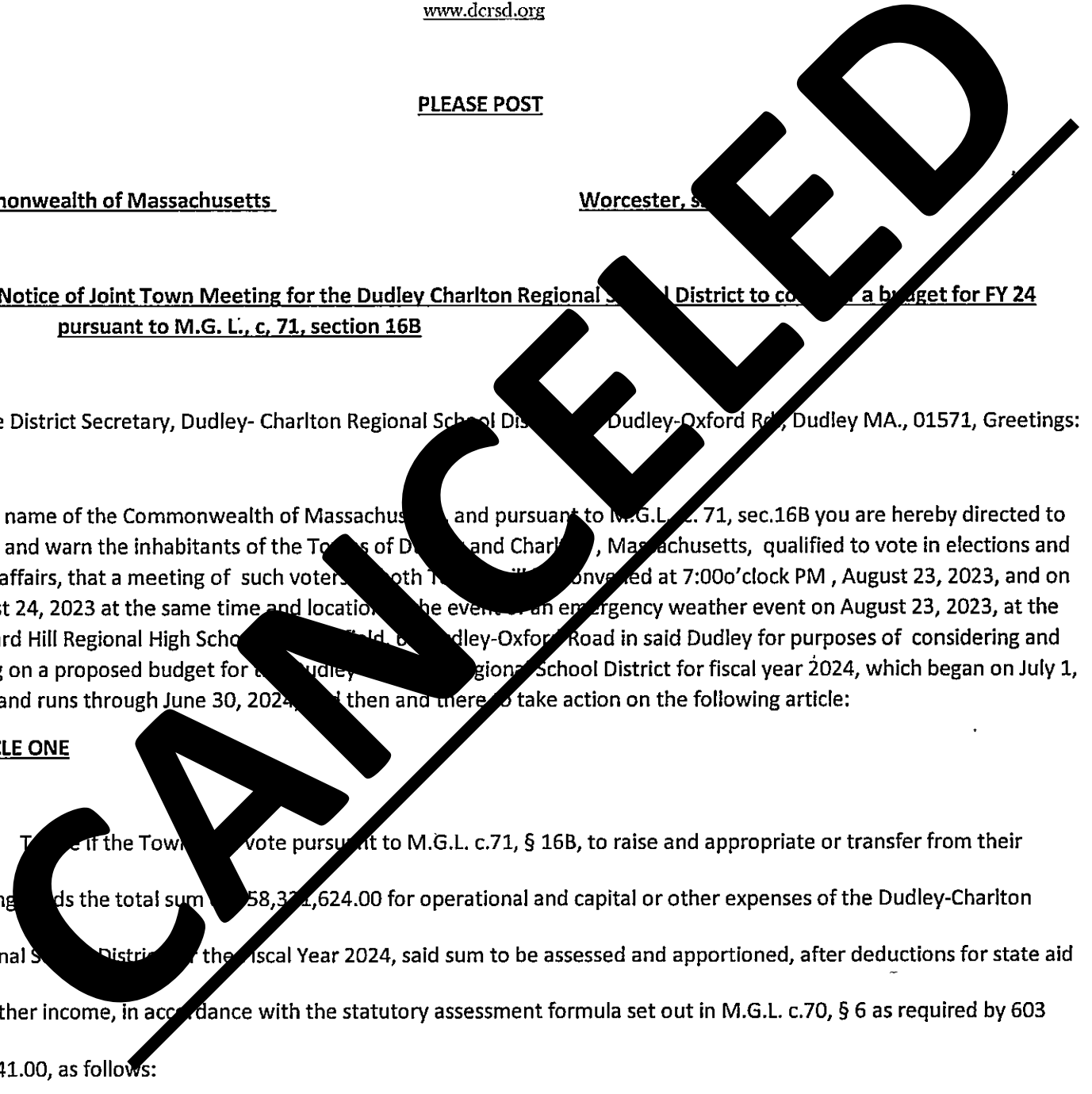
To the District Secretary, Dudley- Charlton Regional School District, 68 Dudley-Oxford Rd, Dudley MA., 01571, Greetings:

In the name of the Commonwealth of Massachusetts and pursuant to M.G.L. c. 71, sec.16B you are hereby directed to notify and warn the inhabitants of the Towns of Dudley and Charlton, Massachusetts, qualified to vote in elections and town affairs, that a meeting of such voters of both Towns will be convened at 7:00o'clock PM , August 23, 2023, and on August 24, 2023 at the same time and location. In the event of an emergency weather event on August 23, 2023, at the Shepard Hill Regional High School, 68 Dudley-Oxford Road in said Dudley for purposes of considering and voting on a proposed budget for the Dudley-Charlton Regional School District for fiscal year 2024, which began on July 1, 2023 and runs through June 30, 2024, and then and there to take action on the following article:

ARTICLE ONE

To-wit: If the Towns shall vote pursuant to M.G.L. c.71, § 16B, to raise and appropriate or transfer from their existing funds the total sum of \$58,371,624.00 for operational and capital or other expenses of the Dudley-Charlton Regional School District for the fiscal Year 2024, said sum to be assessed and apportioned, after deductions for state aid and other income, in accordance with the statutory assessment formula set out in M.G.L. c.70, § 6 as required by 603 CMR 41.00, as follows:

The Town of Dudley will appropriate \$10,937,991.00 and the Town of Charlton will appropriate \$18,357,881.00.



I am hereby directed to serve this warrant by posting attested copies thereof, at the Town Clerk's office, the Public Library, and the Police Stations of the Towns of Dudley and Charlton and by publishing this warrant in the Worcester Telegram and Gazette, a newspaper of general circulation within said towns.

Warrant to be posted at least fourteen (14) days before holding of said meeting. Hereof, fail not, and make do return of this warrant with your doing thereon, to the Regional School Committee of the Board of Selectman.

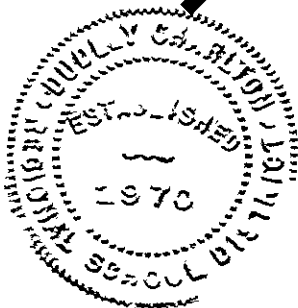
