A Public Meeting of the Planning Board was called to order at 7:00 PM on Wednesday, June 8, 2022 by Guy Horne, Chairman. Members present were Richard Clark, Vice-Chairman, Steve Watroba, Clerk, and William Scanlan, Town Planner. Thomas Chojnacki was absent.

A. <u>New Business:</u>

1. Approval of Meeting Minutes: May 11th & May 23, 2022:

Richard Clark moved to approve the meeting minutes for May 11th 2022. Steve Watroba seconded. All in favor, 3-0-0, unanimous.

Steve Watroba moved to approve the meeting minutes for May 23, 2022. Richard Clark seconded. All in favor, 3-0-0, unanimous.

2. ANR Plans: Shelley Nobert, 45 NW Schoolhouse Road

The Planning Board Members had a question whether the applicant had paid all property taxes. Richard Clark moved to table the Shelley Nobert ANR plan to the next meeting to wait for an answer to this question. Steve Watroba seconded. All in favor, 3-0-0, unanimous.

3. Review Draft Solar Landfill Decision and Possible Action to Approve

The Planning Board approved three waivers requested by the Applicant:

1. A waiver for the front yard setback of 100 feet; the parcels sit behind the Town of Dudley's transfer station off of the existing frontage for Indian Road; a 50-ft side yard setback was used for this parcel boundary.

2. A waiver for the northeast side yard setback from 50 feet to 20 feet; the abutting land is also owned by the Town of Dudley.

3. A waiver for the fence height from 6 feet to 7 feet as a 7-foot high fence is required in order to comply with the requirements of the NFPA 70, National Electric Code (NEC) for electrical enclosures.

The Planning Board members signed the original decision.

4. Sign Steven Mill Decision

The Town Planner made edits to the Steven Mill Decision based on the Planning Board comments from the last meeting. The Planning Board members signed the Final Stevens Mill Decision.

5. Piasta Road: Form J Certificate of Completion and Release of Municipal Interest in Subdivision Performance Security

Richard Clark moved to return the funds to the developer of Piasta Road. Steve Watroba seconded. All in favor, 3-0-0, unanimous.

6. Discussion of Process for Evaluating Betterment Costs for Misty Meadow and Tobin Drive

Guy Horne and Steve Watroba volunteered for the Betterment Working Group to work with the Town Planner and Highway Superintendent to re-examine the completion cost estimates to see if it might be possible to lower the costs without compromising the construction quality.
